Action Plan for Year 2015.

Taking into consideration that in accordance with the Resolution MSC.349 (92) adopted on the 21st of June 2013 Code for Recognized Organizations (RO Code), the provisions of the Code will take effect on the 1st of January 2015.

Maritime Lloyd amended Quality System Procedures for the Code provisions compliance and planned Vertical Control Audits to the field offices and attending surveyors.

The first one is planned to be conducted in May 2015 at Istanbul.

Romania – June 2015.

Bulgaria – June 2015.

Egypt – July 2015.

Netherlands – August 2015.

Examination and Testing program has been provided by Head Office to the field surveyors and basing on the results and local Audit, the work is going to be evaluated in accordance with the Audit Plan and positive results of the VCA at the field.

HO will continue to require from Authorized surveyors to present annually the updated data for any training courses passed by the each Authorized surveyor.

HO will continue to inform all field staff of all requirements, which are coming into force by corresponding Circulars; the proof of understanding of requirements has to be proved by appropriate written confirmation.

The past year showed good dynamic of detention rate decrease. In accordance with PARISMOU RO performance list within 3 years, Maritime Lloyd occupies the strong position at Medium Level.

Maritime Lloyd has fixed in its Quality Policy the goal to decrease the detention rate previous Year as minimum for 1 %, but the percentage of the detention decrease this Year is 2% . This rate is intended to be kept during this Year.

The HO and field surveyors are encouraged to use more effectively preventive actions to minimize the risk of detentions.

New entries in the Year 2014 reached 11 new vessels.

HO is planning to keep this level for the 2015 Year.



The case by case Authorization of the Flag of Republic of Palau has been obtained, so we are planning to give more promotion to the newly gained Authorization.

All surveyors are encouraged to promote from your side accordingly.

In the Year 2015, ML applied to two more Flags Authorization. Results will be informed in the corresponding Circulars.

Vessels which past MLC 2006 surveys have to be followed continuously to avoid any detention for the related items, as PSC will follow cases more strictly this Year.
